**Regarding permission for transfer of management, land & building and change of name, of AKIOD College of Engineering, Village- Lowakhurd, Bahadurgarh from M/s BKK Memorial Trust to M/s RS Educational Foundation.**

Kindly refer to your letter dated 25.01.2024 and letter no. ACE/DTE-DHE/2024/185 dated 14.06.2024 on the subject cited above.

In this connection, it is intimated that in view of provisions given in clause 2.19 and 2.20 of Chapter-2 of APH 2024-25 and further in view of Extension of Approval (EoA) given by the AICTE vide letter no. North-West/1-43662437043/2024/EoA dated 10.06.2024, the competent authority has granted the permission to M/s RS Educational Foundation for *transfer of management, land & building* of Akido College of Engineering, Village Lowakhurd, Bahadurgarh from M/s BKK Memorial Trust to M/s RS Educational Foundation and further permission for *change of name of institute*, as IITM College of Engineering 6 K.M. Mile Stone, Jhajar Road, Village- Lowakhurd, Bahadurgarh-124507 from academic session 2024-25 with the following conditions that:-

- (i) That change in the name of the Trust/ Society/ Company of institute will abide by all terms & conditions as lay down in the Approval Process Handbook 2024-27.
- (ii) That for change in the name of the institution, the the Trust/ Society/ Company of institute shall follow the conditions specified in clauses 2.19 of chapter-2 and clauses 1.5.4 and 1.5.5 of chapter-1 mentioned in the Approval Process Handbook 2024-27.
- (iii) There will be no commercial or business angle for change of M/s BKK Memorial Trust to M/s R S Educational Foundation of the institute.
- (iv) There are no legal issues pending with both old and new Trust/ Society/ Company.
- (v) There are no financial liabilities in the old and new Trust/ Society/ Company.
- (vi) That the liabilities, if any, arise out of change of name of the Trust/ Society/ Company, shall be the solely responsibility of the institute and M/s R S Educational Foundation and shall be settled as per the rules and regulations as applicable.
- (vii) Current staff strength re-arrangements and dues, if any shall be settled by institute/ trust i.e. M/s BKK Memorial Trust and M/s RS Educational Foundation as per norms and regulations as applicable.
- (viii) NOC is being issued subject to fulfillment of terms & conditions of (i) AICTE, (ii) affiliating university and (iii) State Government, rules and regulations as applicable. In the event of Non-Compliance of any norms by RS Educational Foundation or institute, the Government shall be free to take appropriate action including withdrawal of its NOC without consideration of any related issues.
